System: Wakefield Bridge Steel Shingle

Deck Type: Wood, Non-insulated

Deck Description: New Construction $^{19}/_{32}$ " or greater plywood or wood plank, or for re-roofing $^{15}/_{32}$ " or

greater plywood.

Slope Range: 4": 12" or greater

Maximum Uplift

Pressure: See Maximum Design Pressure below

Deck Attachment: In accordance with applicable Building Code, but in no case shall it be less than the

following: Sheathing mechanically fastened to the joists with #8 x 1-3/4" wood screws spaced 6" o.c. In reroofing where the deck is less than $^{19}/_{32}$ " thick (minimum $^{15}/_{32}$ ") the above attachment method must be in addition to existing attachment.

Underlayment: Minimum underlayment shall be an ASTM D 226 Type II installed with a minimum

4" side-lap and 6" end-laps. Underlayment shall be fastened with corrosion resistant tin-caps and 12 gauge 1 ¼" annular ring-shank nails, spaced 6" o.c. at all laps and two staggered rows 12" o.c. in the field of the roll or any approved underlayment having a

current NOA.

Fire Barrier: Any approved fire barrier having a current NOA. Refer to a current fire directory

listing for fire ratings of this roofing system assembly as well as the location of the

fire barrier within the assembly. See Limitation # 1.

Valleys: Valley construction shall be in compliance with Roofing Application Standard RAS

133 and with the current published installation instructions and details in Ideal

Roofing Company Limited Installation Manual.

Metal Panels and Accessories:

Install the "Wakefield Bridge Steel Shingle" including flashing penetrations, valleys, end laps and accessories in compliance "Ideal Roofing Company Limited" current

published installation instructions and in compliance with the minimum requirements

detailed in Roofing Application Standard RAS 133.

Panels shall be secured with corrosion resistant #12 of sufficient length to penetrate through the sheathing a minimum of $^3/_{16}$ " with plastic washers. The screw/washer shall be placed at every available slot in the shingle. (See Detail A) The panels in the next row shall be installed by attaching the bottom of the shingle to the top of the

shingle of the row below. The panel is then secured as described above.

The "Wakefield Bridge Steel Shingle" shall be installed from left to right starting with

a full panel on the first row, 2/3 and 1/3 of a panel on the second and third row.

Repeat the steps for the remainder of the roof section.

-125.95 PSF (See General Limitation #2)


LIMITATIONS

- 2. The maximum designed pressure listed herein shall be applicable to all roof pressure zones (i.e. field, perimeters, and corners). Neither rational analysis, nor extrapolation shall be permitted for enhanced fastening at enhanced pressure zones (i.e. perimeters, extended corners and corners).
- 3. All panels shall be permanently labeled with the manufacturer's name and/or logo, and the following statement: "Miami-Dade County Product Control Approved" or with the Miami-Dade County Product Control Seal as seen below. All clips shall be permanently labeled with the manufacturer's name and/or logo, and/or model.



4. All products listed herein shall have a quality assurance audit in accordance with the Florida Building Code and Rule 61G20-3 of the Florida Administrative Code.
